The parent/s and/or guardian/s must meet the following requirements during any activity held or sanctioned by **Club PERÓ**, Gymnastics NSW, Gymnastics Australia:

APPROPRIATE BEHAVIOUR

1. Respect the rights, dignity and worth of others;
2. Remember that your child participates in sport for their own enjoyment, not yours;
3. Focus on your child's efforts and performance rather than winning or losing;
4. Never ridicule or yell at your child and other children for making a mistake or losing a competition;
5. Show appreciation for good performance by all gymnasts, including gymnasts from other teams;
6. Demonstrate a high degree of individual responsibility especially when dealing with or in the vicinity of persons under 18 years of age, as your words and actions are an example;
7. Respect officials' decisions and teach children to do likewise;
8. Do not physically or verbally abuse or harass anyone associated with the sport (player, coach, judge and so on);
9. Respect the rights, dignity and worth of every young person regardless of their gender, race, place of origin, athletic potential, colour, sexual orientation, religion, political beliefs, socio-economic status and other conditions;
10. Be a positive role model; and
11. Understand the repercussions if you breach, or are aware of any breaches of, this Code of Behaviour.

APPROPRIATE BEHAVIOUR

1. Respect the rights, dignity and worth of fellow students, coaches, officials and spectators;
2. Do not tolerate acts of aggression;
3. Respect the talent, potential and development of fellow students and competitors;
4. Care for and respect the equipment provided to you as part of your program;
5. Be frank and honest with your coach concerning illness and injury and your ability to train fully within the program requirements;
6. At all times avoid intimate relationships with your coach;
7. Conduct yourself in a professional manner relating to language, temper and punctuality;
8. Maintain high personal behaviour standards at all times;
9. Be honest in your attitude and preparation to training. Work equally hard for yourself and your team;
10. Show concern and caution towards others who may be sick or injured; and
11. Cooperate with coaches and staff in development of programs to adequately prepare you for competition at the highest level.
